## Fee Refund Rules

### Applicable for cancellation/withdrawal from the Programme

S.No	Scenario [For all programmes]	Refundable Amount
1.	Intimation of withdrawal received <b>till 5.00 PM on 15<sup>th</sup> December 2022</b>	100% of the amount paid to the institute with a deduction of processing fee Rs.5000/-
2.	Intimation of withdrawal received <b>After 5.00 PM on 15<sup>th</sup> December 2022 till 5.00 PM on 30<sup>th</sup> December 2022.</b>	Refundable Security Deposit of the fee circular (Section-C) Plus 50% of the remaining amount paid to the institute
3.	Intimation of withdrawal received <b>After 5.00 PM on 30<sup>th</sup> December 2022</b>	Only Refundable Security Deposit of the fee circular (Section-C)
