3.	Essential Qualification	1. Ph. D in Mathematics with good academic record or having 3 years of research, teaching and design and development experience in Mathematics with at least one research paper in Science Citation Indexed (SCI) journal. 2. Those who have submitted their Ph.D. thesis and are awaiting for the award of the degree are also eligible to apply. However, these candidates will be considered as SRF till they defend their thesis. After their successful defence of thesis, they will be eligible for Research Associate I.
4.	Desirable Qualification	Minimum 3 years of research experience in functional analysis and partial differential equations is expected
5.	Consolidated Emoluments	Rs. 47,000 per month if thesis defended, else Rs. 35,000 per month+ 16% House Rent Allowance per month
6.	Duration of the tenure	Maximum 3 months
7.	Tenure of appointment	The appointment for the above contractual position will be initially for 3 months, which may be curtailed or extended based on the performance of the candidate, availability of funds in the project and requirement in the project. The appointment will be co-terminus with the project.
8.	Age Limit	Not exceeding 35 years as on the date of the selection process.

Documents Required	Applicant should have an online version of all original certificates including mark sheets (matriculation onwards), experience certificate(s), monthly emoluments/salary drawn, and all other relevant documents (including one set of the self-attested certificate(s)/document(s) and updated Curriculum Vitae.

General Instructions to the applicants:

1	Selected candidates shall not have claim on any regular position and shall not be bestowed any of the privileges like Housing, Medical Facility and Other benefits available to regular employees of the Institute.
2	Applicants are advised to ensure, before appearing for the Selection Process, that they possess the minimum essential qualification and experience laid down for the post. Qualification obtained has to be from a recognized University/Institute. Eligibility in terms of age, qualification and experience of a candidate shall be considered as on the date of Selection Process.
3	The number of vacancies indicated in the notification is tentative. IIT Dharwad reserves the right to increase or decrease the number of advertised posts at the time of selection. Further, IIT Dharwad reserves the right to NOT fill any of the posts advertised.
4	No TA/DA will be paid for attending the Selection Process.
5	In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issue of the appointment letter, the Institute reserves the right to <i>modify, withdraw</i> or <i>cancel</i> any communication made to the Applicants.
6	After joining the service of the Institute, the person(s) will have to abide by the Rules, Regulations, Ordinances, Statutes and Act of the Institute applicable from time to time. He/She may be assigned any duty within or outside the Institute depending upon the exigency of the work.
