Documents Required	Applicant should have online version of all original certificates including mark sheets (matriculation onwards), experience certificate(s), monthly emoluments/salary drawn, and all other relevant documents (including one set of self-attested certificate(s)/ document(s) and updated Curriculum Vitae.

**General Instructions to the applicants:**

Eligibility in terms of age, qualification and experience of a candidate shall be considered as on the date of Selection Process.

4	No TA/DA will be paid for attending the Selection Process.
